#### Summary of Events

#### Alarms:

Deputies responded to 5 residential alarms that was cleared as false alarms.

#### Traffic Enforcement:

Deputy conducted numerous traffic stops and traffic initiatives throughout the contract during the month in the interest of public safety and in an attempt to reduce the risk of motor vehicle accidents.

#### Contract Checks:

Deputies conducted 46 combined contract and park checks during the month.

#### Burglary Motor Vehicle:

19000 Forest Fern Dr – Deputy responded to a burglary of a motor vehicle call. Investigation revealed unknown suspect (s) unlawfully entered two unlocked vehicles, stole property, and fled undetected.

#### Theft Other:

5700 Enchanted Timbers Dr – Deputy responded to a theft call. Investigation revealed unknown suspect (s) stole tires and wheels from the complainant's detached garage and fled undetected.

#### Assault:

19000 River Brook Ct – Deputy responded to a disturbance call. Investigation revealed the defendant pointed a weapon at a Peace Officer and was arrested for Aggravated Assault on a Peace Officer. The defendant was booked into the Harris County Jail. No injuries.

19000 Atasca Oaks Dr – Deputy conducted a traffic stop on a vehicle. During the course of the investigation the driver intentionally struck the Deputy with his vehicle door causing minor injury. The driver was arrested for Assault on a Peace Officer and possession of a controlled substance.

19000 Merrillwood Dr – Deputy responded to a family assault call. Investigation revealed that the complainant was assaulted at a different location and injured. The Deputy filed an arrest warrant and the defendant was arrested after the fact.

19000 River Brook Ct – Deputy responded to a family disturbance call. Investigation revealed an intoxicated family member threatened the complainant with a weapon. The defendant was arrested and charged with aggravated assault – family member.

#### Family Disturbance:

5600 Enchanted Timbers Dr – Deputy responded to a family disturbance. Investigation revealed family members had a verbal altercation which ended without injury. A civil matter was included regarding the use of a vehicle as well.

19000 Oak Branch Ct – Deputy responded to a family disturbance call. Investigation revealed family members engaged in a verbal altercation which ended without injury. Charges were

declined.

19000 Oak Green Ct - Deputy responded to a family disturbance call. Investigation revealed family members engaged in a verbal altercation which ended without injury.

Other Calls:
