Summary of Events

Alarms:

Deputies responded to 6 residential alarms that were cleared as false alarms.

Traffic Enforcement:

Deputy conducted numerous traffic stops and traffic initiatives throughout the contract during the month in the interest of public safety and in an attempt to reduce the risk of motor vehicle

accidents.

19700 Faye Oaks Ct. – Deputy conducted a traffic stop. Investigation revealed that the passenger of the vehicle was in possession of marijuana. Arrest report was completed.

Contract Checks & Park Checks:

Deputies conducted 36 combined contract and other miscellaneous checks in the contract during the month.

Theft Residence:

19700 River Brook Ct. – Deputy responded to a Theft/Residence call. Investigation revealed that unknown subject removed property from the residence without the effective consent of the owner. Investigation pending, and a report was completed.

Assault:

5700 Timbers Trail Dr. – Deputy responded to a Family Assault call. Investigation revealed complainant was assaulted by a known family member. Arrest warrant issued, and a report was completed.

Family Disturbance:

5900 Silent Oaks Dr. – Deputy responded to a Family Disturbance. No physical assault occurred, and no charges were filed. Report was completed.

Telephone Harassment:

5500 Green Timbers Dr. – Deputy responded to a Telephone Harassment call. Investigation revealed that the complainant is continuously contacted by her ex-boyfriend. No threats of violence. Report generated.

Other Reports:

5400 Enchanted Timbers Dr – Deputy responded to a Fraudulent Use of ID call. Investigation revealed that unknown subject scammed the complainant into changing their cell service, and obtained her personal information. A report was completed.

6000 Silent Oaks Dr – Deputy responded to a credit card abuse call. Investigation revealed unknown suspect used the complainant's pay pal account and credit card information to make several unauthorized purchases. Follow up was conducted with possible suspect and their identity was stolen as well. Suspects are unknown and a report was completed.

19500 Forest Fern Dr – Deputy responded to a meet the citizen call. Investigation revealed the complainant wished to file a report regarding a civil matter over the sale of real estate. A report was completed and they were referred to civil court.
