Alarms:

#### Burglary of a Motor Vehicle:

19700 Oak Branch Ct – Deputy responded to a burglary of a motor vehicle call. Investigation revealed an unknown suspect made unlawful entry into the complainant's unlocked vehicle and stole items. The suspect fled the scene undetected, and the investigation is pending. Report was completed.

#### Assault:

6000 Ancient Oaks Dr – Deputy responded to a family assault call. Investigation revealed the complainant was involved in a physical altercation with their ex-spouse, and suffered bodily injury. Suspect was not on scene, and a to-be warrant was filed in this case. Report was completed.

Investigation revealed that the defendant was observed assaulting the complainant on a public roadway. The defendant was arrested for Continuous Family Assault, and booked into the Harris County jail. Arrested report was completed.

#### Family Disturbance:

6000 Gnarled Oaks Dr – Deputy responded to a family disturbance call. Investigation revealed complainant and suspect were involved in a mutual combat family assault. No charges at this time. Report was completed.

#### Runaway:

5900 Upper Lake Dr – Deputy responded to a Runaway call. Investigation revealed that the juvenile in question was a runaway from HPD, and had stolen their parent's vehicle when they were pulled over by a State Trooper. The runaway was recovered by their parents. Report was completed.

the juvenile resident left without the effect consent of their guardian. Juvenile returned home the following day. Report was completed

Other Reports:
