#### Summary of Events

Alarms:

Deputies responded to 16 alarms that were cleared as false alarms.

#### Contract Checks:

Deputies conducted 59 combined contract and park checks during the month.

#### Traffic Enforcement:

Deputy conducted numerous traffic stops and traffic initiatives throughout the contract during the month in the interest of public safety and in an attempt to reduce the risk of motor vehicle accidents.

5800 Upper Lake Dr – Deputy conducted a traffic stop on a vehicle. Investigation revealed the driver to be in possession of marijuana. The driver was arrested for possession of marijuana in a drug free zone and booked into the Harris County Jail.

#### Burglary Motor Vehicle:

5600 Mossy Timbers Dr – Deputy was dispatched to a burglary of a motor vehicle call. Investigation revealed unknown suspect(s) unlawfully entered the complainant's unlocked vehicle and rummaged through the belongings. No damage to the vehicle and no items were reported stolen. Report completed.

#### Stolen Vehicle:

19000 Atasca Oaks Dr – Deputy responded to a stolen vehicle call. Investigation revealed unknown suspect (s) stole the complainant's vehicle from the driveway and fled undetected. The vehicle was found four days later in Houston and recovered.

#### Assault:

5500 Moosewood Ct – Deputy was dispatched to an assault call. Investigation revealed known subjects engaged in a verbal altercation which became physical and ended with minor injuries. The District Attorney's Office declined charges due to mutual combat. Report completed.

19000 River Brook Ct – Deputy was dispatched to a family disturbance call. Investigation revealed known family member assaulted two family members. The male was arrested and charged with two counts of assault family member. Report completed.

#### Family Disturbance:

5400 Palamino Ct – Deputy was dispatched to a family disturbance call. Investigation revealed family members engaged in a verbal altercation which became physical and ended without injury. No charges were filed and a report was completed.

5700 Enchanted Timbers Dr - Deputy was dispatched to a family disturbance call. Investigation revealed family members engaged in a verbal altercation which became physical and ended without injury. No charges were filed and a report was completed.

#### Runaway:

5600 Enchanted Timbers Dr – Deputy responded to a runaway call. Investigation revealed the juvenile left the residence without permission. The juvenile was later found in Galveston County and arrested.

Other Calls:

19000 Oak Branch Ct – Deputy was dispatched to an information call. Investigation revealed that the complainant was videotaped without her permission within the home. The District Attorney's Office reviewed the case and the video and declined any charges. Report completed.

6000 Silent Oaks Dr – Deputy responded to an Fraud call. Investigation revealed the complainant fell for a scam over the phone and provided personal information. Afterwards, the complainant learned it was a scam and requested a report in case his identity is used.
