#### Summary of Events

##### Alarms:

Deputies responded to 5 residential alarms that were cleared as false alarms.

##### Traffic Enforcement:

Deputy conducted numerous traffic stops and traffic initiatives throughout the contract during the month in the interest of public safety and in an attempt to reduce the risk of motor vehicle accidents.

19600 Timber Forest Dr. – Deputy conducted a traffic stop. Investigation revealed that the driver

was driving while license was invalid with no insurance. Vehicle was towed, and report was completed.

5900 Upper Lake Dr. – Deputy responded to a one vehicle accident. Investigation revealed that the driver was driving intoxicated. Defendant was arrested and booked for DWI and arrest report was completed.

#### Contract Checks & Park Checks:

Deputies conducted 52 combined contract and other miscellaneous checks in the contract during the month.

#### Burglary Motor Vehicle:

19700 Big Timber Dr. – Deputy responded to a Burglar of Vehicle call. Investigation revealed that unknown suspect made unlawful entry into vehicle and removed items. Report was completed, and the investigation is pending further leads.

#### Theft Residence:

5900 Silent Oaks Dr – Deputy responded to a theft from residence. Investigation unknown suspect stole identification documents from within the house and fled undetected.

#### Criminal Mischief:

5700 Ancient Oaks Dr . – Deputy responded to a Criminal Mischief call. Investigation revealed an unknown suspect damaged property and fled undetected. Report was completed.

#### Family Disturbance:

5900 Ancient Oaks Dr. – Deputy responded to a family disturbance call. Investigation revealed complainant was assaulted by their spouse and did not wish to pursue charges. The Harris County DA's Office was contacted and charges were declined. Report was completed.
