Summary of Events

Alarms:

Deputies responded to 2 residential alarms that were cleared as false alarms.

Traffic Enforcement:

Deputy conducted numerous traffic stops and traffic initiatives throughout the contract during the month in the interest of public safety and in an attempt to reduce the risk of motor vehicle accidents.

5700 Upper Lake Dr – Deputy conducted a traffic stop. Investigation revealed the driver was operating while their license was invalid. Harris county DA's office accepted charges of DWLI. Arrest report was completed.

Contract Checks & Park Checks:

Deputies conducted 54 combined contract and other miscellaneous checks in the contract during the month.

Family Disturbance:

19400 Atasca Oaks Dr – Deputy responded to a Family Assault call. Investigation revealed the complainant was assaulted by their juvenile son while in Puerto Rico. Complainant wanted incident documented, and did not wish to pursue charges due it happening out of State. Report was completed.

19700 Oak Green Ct – Deputy responded to a family assault call. Investigation revealed complainant was assaulted by husband and did not want to pursue charges. The defendant had an active Protective Order against him. The Harris County DA's Office was contacted over the assault and charges for the assault were declined, but accepted charges for Violation of Family Protective Order. Arrest report was completed.

Assault:

5600 Enchanted Timbers Dr – Deputy responded to an Assault call. Investigation revealed the complainant was assaulted by an acquaintance. Investigation pending at this time. Report was completed.

Telephone Harassment:

5700 Timbers Trail Dr. – Deputy responded to a Telephone Harassment call. Investigation revealed the complainant was being harassed by a known suspect via cell phone. Suspect in this case is attempting contact in order to retrieve items from residence after being evicted. No charges. Report was completed.

Theft:

19500 Alinawood Dr. – Deputy responded to a Theft of Residence call. Investigation revealed the complainant and suspect are going through a divorce, and the suspect took her work-issued laptop during their separation. Report was completed.

Theft Other:

5600 Enchanted Timbers Dr. – Deputy responded to a Theft other call. Investigation revealed the complainant paid a private contractor to do repairs on his home. Complainant was advised that the issue was civil in nature, and requested a report for small claims court. Report was completed.

19500 Forest Fern Dr – Deputy responded to a Theft call. Investigation revealed that the complainant's trailer from his residence. No suspects at this time, and investigation is pending. Report was completed.

Other Reports:

5500 Green Timbers Dr – Deputy responded to a Fraud type call. Investigation revealed the complainant's identity was compromised, and used to open a fraudulent account on PayPal. Report was completed.

5700 Forest Timbers Dr. – Deputy responded to a Suspicious Vehicle call at the park after posted hours. Investigation revealed the subject was a fugitive with an active warrant, and failed to identify herself to responding deputies. Subject arrested for Fail To ID (Fugitive). Arrest report was completed.
