### Summary of Events

#### Alarms:

Deputies responded to 7 residential alarms that were cleared as false alarms.

#### Traffic Enforcement:

Deputy conducted numerous traffic stops and traffic initiatives throughout the contract during the month in the interest of public safety and in an attempt to reduce the risk of motor vehicle accidents.

#### Contract Checks & Park Checks:

Deputies conducted 55 combined contract and other miscellaneous checks in the contract during the month.

#### Burglary Motor Vehicle:

6000 Gnarled Oaks Ct. – Deputy responded to a Burglary of a Motor Vehicle call. Investigation revealed that the complainant went on vacation, and left his vehicle unlocked. Complainant returned home to find his handguns had been stolen out of his vehicle. All firearms were entered into the TCIC/NCIC system, and investigation is pending. Report was completed.

#### Theft Residence:

5700 Timbers Trail Dr. – Deputy responded to a Theft of Residence call. Investigation revealed that the complainant believed his handgun was stolen by a contracted worker. No charges at this time. Report was completed.

#### Theft Other:

5800 Enchanted Timbers Dr. – Deputy responded to a Theft other call. Investigation revealed that a known juvenile suspect stole the complainant's juvenile's bicycle. Bicycle was recovered by deputy and returned. Complaining party did not wish to pursue charges. Report was completed.

#### Assault:

19700 River Brook Ct – Deputy responded to an Assault call. Investigation revealed the complainant was assaulted by an acquaintance. No pain was felt by either party, and no charges filed.. Report was completed.

#### Criminal Mischief:

5900 Bent Tree Ct. – Deputy responded to a Criminal Mischief call. Investigation revealed that the complainant's house was vacant, and was found with damages to the front door. Nothing was missing from the residence, and there are no suspect leads. Report was completed.

#### Family Disturbance:

19700 Bambiwoods Ct. – Deputy responded to a Family Disturbance call. Investigation revealed the complainant was alleging that that they were assaulted by their spouse dating back 5 years. The incidents are said to have occurred outside of Harris County (Kansas). No assault is said to have occurred at this time. Report was completed.

5600 Kiowa Timbers Dr. – Deputy responded to a Family Assault call. Investigation revealed the complainant was assaulted by their sibling. Incident was found to be mutual combat, and no charges filed. Report was completed.

#### Telephone Harassment:

5600 Enchanted Timbers Dr. – Deputy responded to a Telephone Harassment call. Investigation revealed the complainant was being harassed by a known suspect via cell phone. Suspect in this case is attempting contact, and the complainant blocked the accounts. No charges. Report was completed.

**Other Reports:**

19400 Forest Timbers Ct. – Deputy Responded to Fraud call. Investigation revealed that the complainant's identity was being used out of State. Report was completed.

5900 Gnarled Oaks Ct. – Deputy responded to an In Progress call that was later changed to an Information call. Investigation revealed that an unidentified male called 9-1-1 with a hoax call. All members of the household were unharmed, and the call was determined to be fake. Report was completed.

19700 Bambiwoods Ct – Deputy Responded to a Domestic Prevention call that was later changed to a Disorderly Conduct. Investigation revealed that the defendant displayed a handgun during a verbal argument. Defendant arrested and booked for Disorderly Conduct. Arrest report was completed.
